

Members Committee Two Hundred Thirty-Fourth Meeting PJM Conference and Training Center, Audubon, PA / WebEx January 25, 2023 1:15 p.m. – 5:00 p.m. EPT

Administration (1:15-1:20)

David Scarpignato, Members Committee Chair, welcomed stakeholders to the meeting.

A. David Anders announced the following new member companies approved for PJM membership since the last meeting:

He noted that three members had withdrawn since the last meeting and that the total membership stands at 1116. Thirty withdrawn members await FERC approval prior to their membership being terminated.

- C. David Anders reminded participants of Antitrust, Code of Conduct, and Meeting Participation guidelines.

- C. Proposed Tariff and OA revisions addressing the alignment of PJM's authority in event of a default. <u>Issue Tracking: Market Participant Default Flexibility</u>
- D. Proposed clarifying Tariff and OA revisions as endorsed by the Governing Documents Enhancements and Clarifications Subcommittee (GDECS).



Endorsements

1. Manual 34 Revisions

Adrien Ford, ODEC, moved and Jim Benchek, Monongahela Power Company, seconded a Main Motion for proposed revisions to Manual 34: PJM Stakeholder Process addressing motions for new issues at the Members Committee. Greg Poulos, CAPS, offered a proposed amendment to change the word "must" to "should" in the second sentence of the proposed new section 9.51. This was not accepted by the mover and seconder, and therefore it was not incorporated into the motion. Following discussion, the proposed revisions were **approved** by acclamation with eight objections and five abstentions.

2. Capacity Interconnection Rights for ELCC Resources

David Scarpignato reviewed the activities of the Markets & Reliability Committee (MRC) at its January 25, 2023 meeting related to the Capacity Interconnection Rights (CIR) for ELCC Resources issue. Same day endorsement was sought at the MRC and Members Committee.

Tom Hoatson, LS Power, offered a proposed amendment to Tariff Part IV, Subpart J, section 400: Transmission System Capability as follows:

"To prevent hoarding or the potential for the exercise of market power by resources without a BRA must-offer obligation and also to ensure that the transmission system capability allocation will be used, any resource that submits a request to participate in the Transitional System Capability Study shall be required to utilize the CIRs acquired and submit an offer in the BRA for the Delivery Year for which the incremental CIR allocation was granted."

Susan Bruce, PJM ICC, suggested removing the following from the first sentence: "To prevent hoarding or the potential for the exercise of market power by resources without a BRA must-offer obligation and also". Tom Hoatson accepted this suggestion; therefore the updated proposed amendment was as follows:

"To ensure that the transmission system capability allocation will be used, any resource that submits a request to participate in the Transitional System Capability Study shall be required to utilize the CIRs acquired and submit an offer in the BRA for the Delivery Year for which the incremental CIR allocation was granted."

Following additional discussion, Tom Hoatson updated the proposed amendment as follows:

"To ensure that the transitional system capability allocation will be utilized, any resource that submits a request to participate in the transitional system capability study shall utilize the transitional system capability acquired and submit an offer in the BRA or is committed in an FRR Plan, as applicable, for the Delivery Year for which the transitional system capability allocation was granted."

John Brodbeck, EDP Renewables, and Emanuel Esquivel, Enel NA, objected to this proposed amendment, and therefore it was not incorporated into the Main Motion. Tom Hoatson moved and Alex Stern, PSEG, seconded as an Alternate Motion the Main Motion incorporating his proposed amendment.



The Main Motion consisting of proposed solution package I and associated Tariff and Reliability Assurance Agreement revisions were <u>endorsed</u> in a sector-weighted vote with 4.438 in favor. <u>Issue Tracking: Capacity Interconnection Rights (CIR) for ELCC Resources</u>
