
BTMG Configurations

Retail BTM

Serves load for one retail electricity customer.

Non-Retail BTM

Used by EDC/Muni/Coop to serve load of multiple retail electricity customers.

Full BTMG

- No capability designated as Capacity Resource and/or Energy Resource
- Unit is not modeled as generation resource participating in PJM Markets

Partial BTMG

- A portion of capability is designated as Capacity Resource and/or Energy Resource
- Unit is modeled as generation resource participating in PJM Markets



- Change to Capacity Resource and/or Energy Resource status represents an increase in the MW of capability designated as Generation Capacity Resource and/or Energy Resource
 - Generation Interconnection Request must be submitted
 - ISA/WMPA indicates the MW of capability designated as Capacity MWs
 (CIRs) and/or Energy MWs
- Change to BTMG status represents a decrease in the MW of capability designated as Generation Capacity Resource and/or Energy Resource
 - Removal from Generation Capacity Resource Status business rules apply
 - Necessary Study request may be required
 - Results in the amendment or termination of ISA/WMPA
