ADMINISTRATION

Mr. Kormos welcomed the Members and Mr. Anders provided the Anti-trust and Code of Conduct announcements.

ENDORSEMENTS/APPROVALS

1. ADMINISTRATION

Minutes of the January 31, 2013 Markets and Reliability Committee (MRC) meeting were **approved** by acclamation with no objections and one abstention.

2. PJM MANUALS

- A. Mr. Sitarchyk will review changes to Manual 40: Training and Certification Requirements.
- B. Mr. Sims will present proposed revisions to Manual 14B: PJM Region Transmission Planning Process to clarify the light load analysis section, SOL/IROL definition in Planning, and regarding communication of modeling information between PJM and its member companies.
- **C.** Mr. Colby will review proposed revisions to the OASIS Regional Practices document to address the removal of internal sources and sinks. Mr. Eric Hsia will present corresponding revisions to Manual 28: Operating Agreement Accounting.
- D. Mr. Schweizer will review changes to Manual 39: Nuclear Plant Interface Coordination. The committee was asked to endorse the proposed revisions at this first reading.

Following discussion, the MRC **endorsed** the proposed revisions by acclamation with no objections and one abstention.

3. UP-TO CONGESTION TRANSACTION ENHANCEMENT

Mr. Bresler reviewed a proposal to apply volume limitations to up to congestion transactions similar to those that apply to increment offers and decrement bids, and to move the specific limitation from the Tariff to Manual M-11. He discussed the addition of a definition of Up To Congestion Transactions included in the proposed Tariff revisions, as well as the September 17, 2010 FERC order in which the FERC acknowledged the Up To Congestion product.



Stakeholders discussed a desire to have a larger discussion regarding virtual transactions, operating reserves and cost causation. Mr. Scarpignato moved and Mr. Tatum seconded to defer voting on this item for up to two meetings to allow special meetings of the MRC to develop adjustments to the definition of the Up To Congestion product incorporated in the proposed Tariff revisions. Following discussion the Members approved the motion to defer by acclamation with no objections and three abstentions. Members also noted that the issue being considered by the Market Implementation Committee (MIC) regarding FTR Forfeiture Rule application to Up To Congestion transactions is related to the definition issue. Members and PJM staff indicated the desire for that issue to proceed recognizing that the definitional issue would be resolved at the MRC. Members also discussed the concept of a broader review of virtual transactions and noted that a separate problem statement may be brought to the MIC for such a review.

4. <u>CAPACITY SENIOR TASK FORCE (CSTF)</u>

- A. Ms. Burlew discussed an adjustment to the New Entrant Price Adjustment mechanism developed by the CSTF. Following discussion the Members <u>endorsed</u> the proposed revisions by acclamation with no objections and two abstentions.
- B. This item was deferred to a future meeting.

5. SYSTEM RESTORATION STRATEGY SENIOR TASK FORCE (SRSTF)

Ms. Hendrzak presented the recommendations of the SRSTF regarding updates to system restoration strategy. She noted the progress that had been made by the SRSTF since the last MRC meeting in reaching consensus on the remaining components of the strategy. Following discussion the Members **endorsed** the proposed strategy and associated Manual and Tariff revisions by acclamation with no objections and three abstentions.

6. DEMAND RESPONSE PROPOSALS

Mr. Langbein reviewed several proposals developed by the Demand Response Subcommittee.

- A. Emergency Measurement and Verification This proposal included rule changes to 1) determine DR emergency energy settlements based on economic CBL, if available 2) clarify that energy in hours where DR was dispatched for economics and emergency will be settled under emergency rules and 3) exclude emergency event days from the determination of economic CBL.
- B. Demand Response Enhanced CSP Reported Information This proposal included rule changes to expand and clarify information reported by Curtailment Service Providers on the source of DR capability, business segment and on-site generation attributes.
- C. Demand Response Duplicate Registration Resolution This proposal included rule changes to determine the resolution process used when different Curtailment Service Providers register the same end use customer.

Following discussion, the members **endorsed** the proposed manual, Tariff, and OA revisions by acclamation with one objection and three abstentions.

7. BALANCING CONGESTION

Mr. Singh provided a presentation regarding the severity or FTR underfunding Since December 2012. Mr. Lieberman presented proposed Tariff and OA revisions regarding removal of Market-to-Market payments from the Balancing Congestion calculation. Mr. Lieberman moved and Mr. Rohrbach seconded the posted resolution and proposed Tariff and OA revisions. Following discussion, the members <u>failed</u> to endorse the motion in a sector-weighted vote with 1.57 in favor.

8. TARIFF CLEANUP

Ms. Tribulski discussed a proposed cleanup revision to the Tariff regarding the Interconnection Process provisions. Following discussion, the members **endorsed** the proposed revisions by acclamation with no objections and one abstention.



FIRST READINGS

9. DR PLAN ENHANCEMENTS

Mr. Callis reviewed proposals addressing revisions to planned demand response resource requirements developed by special sessions of the Market Implementation Committee. The committee will be asked to endorse these changes at its next meeting.

10. APPLICATION OF FTR FORFEITURE RULES TO UP-TO CONGESTION TRANSACTIONS

Mr. Bresler discussed proposed application of FTR forfeiture rules to up-to congestion transactions. The committee will be asked to endorse these OA and Tariff revisions at its next meeting.

11. FIXED OPERATING RESERVE RATE PROBLEM STATEMENT

This item was withdrawn from the agenda by the proposer.

12. SPS SCHEMES

Mr. Kormos noted that a presentation on the processes for implementation of SPS schemes, focusing on coordination between PJM and Transmission Owners, was made to the Planning Committee, and was posted with the materials for this meeting.

13. <u>INTERMITTENT CAPACITY RESOURCES</u>

Mr. Batta presented a problem statement regarding Calculating Capacity Values for Intermittent Capacity Resources. The committee will be asked to approve the proposed problem statement at its next meeting.

14. PJM MANUALS

- A. Mr. Bryson reviewed changes to Manual 37: Reliability Coordination. The committee will be asked to endorse these changes at its next meeting.
- B. Mr. Schweizer reviewed changes to Manual 03: Transmission Operations due to voltage schedule clarification. The committee will be asked to endorse these changes at its next meeting.
- C. Mr. Schweizer reviewed changes to Manual 14D: Generator Operational Requirements. The committee will be asked to endorse these changes at its next meeting.
- D. Mr. Hsia reviewed revisions to Manual 28: Operating Agreement Accounting to reflect the implementation of market to market coordination with NYISO and changes to Day Ahead Operating Reserve cost allocation. The committee will be asked to endorse these changes at its next meeting.
- E. Mr. Ogburn discussed proposed revisions to Manual 11: Energy & Ancillary Services Market Operations. The committee will be asked to endorse these changes at its next meeting.

FUTURE AGENDA ITEMS

Mr. Schofield requested a presentation at the next MC Webinar regarding the recent change to operating reserves related to load rejection units.
