ADMINISTRATION (9:00-9:05)

Mr. Kormos welcomed stakeholders to the meeting and Mr. Anders provided the Anti-trust and Code of Conduct announcements.

ENDORSEMENTS/APPROVALS

1. DRAFT MINUTES (9:05-9:10)

Minutes of the January 22, 2015 Markets and Reliability Committee (MRC) meeting were **approved** by acclamation with no objections or abstentions.

2. PJM MANUALS (9:10-9:40)

- A. Mr. Jeff McLaughlin reviewed changes to Manual 02: Transmission Service Request to provide greater clarity and to more accurately reflect current long-term firm Initial Study process.
- B. Mr. Frankie Sanchez presented proposed revisions to Manual 14A: Generation and Transmission interconnection Process regarding Data Sheet addition.
- C. Mr. Mark Sims presented proposed revisions to Manual 14B: PJM Regional Transmission Planning Process detailing the process used for RTEP Long Term Analysis and several cleanup changes regarding Voltage Drop



Analysis, Generator Deliverability Analysis, Load Deliverability Analysis and Cost Allocation sections of the manual.

- D. Mr. Glen Boyle presented revisions to Manual 40: Training and Certifications Requirements developed during the annual review of the manual.
- E. Mr. David Schweizer discussed minor ministerial revisions to Manual 14D: Generator Operational Requirements which were recently issued regarding the previously endorsed revisions implementing TO Data Feed.

Following discussion, the proposed revisions in items 2.A, - 2.E were **endorsed** by acclamation with no objections or abstentions.

3. PJM/MISO COORDINATED TRANSACTION SCHEDULING (9:40-10:00)

Ms. Becky Carroll will discuss the proposed PJM-MISO Coordinated Transaction Scheduling (CTS) efforts to develop an additional scheduling product. Following discussion the Committee endorsed the proposed CTS by acclamation with no objections and two abstentions.

FIRST READINGS

4. <u>FTR REVISIONS (10:00-10:15)</u>

Mr. Tim Horger presented non-substantial FTR revisions. The committee will be asked to endorse the revisions its next meeting.

5. CT LOST OPPORTUNITY COST (10:15-10:30)

Mr. Adam Keech presented revisions to rules regarding treatment of CT Lost Opportunity Cost developed by the Energy Market Uplift Senior Task Force. The committee will be asked to endorse the revisions its next meeting.

6. <u>DEMAND RESPONSE FORECAST FOR USE IN RTEP (10:30-10:45)</u>

Mr. Tom Falin discussed a proposed change to demand response modeling assumptions in Load Deliverability Analysis. The committee will be asked to endorse the revisions its next meeting.

7. PJM MANUALS (10:45-11:15)

- A. Mr. Tong Zhao presented revisions to Manual 11: Energy & Ancillary Services Market Operations regarding Demand Bid Screening. The Committee will be asked to endorse the proposed revisions at its next meeting.
- B. Mr. Jeff Bastian presented proposed revisions to Manual 18: PJM Capacity Market regarding implementation of Capacity Performance. Mr. Kormos noted that an additional session would be scheduled to allow stakeholders to continue review of the proposed Manual revisions. The Committee will be asked to endorse these proposed revisions at a future meeting should the FERC accept the recent Capacity Performance related filings.

8. <u>FERC ORDER 1000 (11:15-11:30)</u>

Mr. Steve Herling discussed the recent FERC ruling on PJM's Order 1000 compliance filing and proposed revisions. The Committee will be asked to endorse the proposed revisions at its next meeting. The Members Committee will also be asked to approve of the proposed revisions at its next meeting.

9. <u>DEMAND RESPONSE "STOP GAP" FILING (11:30-11:45)</u>

Mr. Stu Bresler discussed potential impacts on the 2018/19 Base Residual Auction of the timing and potential outcomes of the pending Supreme Court action in the EPSA case.

10. RELIABILITY MUST RUN CONTRACTS



Mr. Mike Kormos discussed the PJM filing which sought the ability for PJM to enter into contracts with certain generating resources to extend their retirement dates, including the FERCs response to the filing. He indicated that PJM does not intend to pursue any additional action in this matter.
