## Administration

Mr. Stu Bresler and Mr. Dave Anders welcomed stakeholders.

Mr. Chuck Dugan, EKPC and Members Committee (MC) Chair, and Mr. Steve Lieberman, AMP and MC Vice Chair, recognized Ms. Denise Foster, PJM Vice President, State and Member Services, on the occasion of her departure from PJM. On behalf of the Members, Mr. Dugan and Mr. Lieberman thanked Ms. Foster for her service to the Members and wished her well in future endeavors.

Mr. Bresler echoed the remarks of Mr. Dugan and Mr. Lieberman, noting Ms. Foster's many contributions to PJM and likewise extending best wishes in the future.

Mr. Anders provided the Anti-trust and Code of Conduct announcements and noted that PJM will be updating its current stakeholder email communication tool later this year. Stakeholders were asked to provide their IT departments the IP address, 13.111.63.217, to ensure members receive stakeholder communications from the new tool. If subscribers are unable to add the IP address to their list of approved senders, they should check the company spam folder to allow communications from "@lists.pjm.com". ## Endorsements/Approvals (9:15-9:30)

### 1. Load Management Testing Requirements

Mr. Pete Langbein provided a review of the Load Management Test proposals endorsed by the Market Implementation Committee. He discussed development of proposed friendly amendments that resolve

differences between the proposed solutions. Ms. Susan Bruce proposed the following friendly amendments:

- Change Tier 1 notification from month ahead to 2 weeks ahead (by Monday or first business day prior to start of test period):
  - No changes to Tier 2 (day ahead) and Tier 3 (test day lead time)
- Timing of request for Retest if CSP has issue (delivers less than 75% of the committed MWs) with the Test:
  - First Read version - PJM directed retest upon CSP request before the end of month after the test.
    - CSP given 30 to 60 days after to test to request retest, as needed.
  - Modified version - PJM directed retest upon CSP request before the 46th day after the test.

There were no objections to these proposed friendly amendments, and therefore they were incorporated into the main motion. Following discussion, the main motion was **endorsed** by acclamation with one objection and one abstention.

Mr. Brian Chmielewski reviewed proposed OA and Manual 6: Financial Transmission Rights revisions related to the Financial Risk Mitigation Senior Task Force (FRMSTF) endorsed solution package for FTR Product Range and Auction Process. The committee will be asked to endorse the revisions at its next meeting.

## 7. Modeling Generation Senior Task Force (MGSTF) (11:15-11:30)

Mr. Stan Williams provided an overview of the Modeling Generation Senior Task Force recommended long-term implementation plan with near-term implementation proposals. The committee will be asked to endorse the proposed solution packages at its next meeting.
