### **Review of Operations**

### 4. Review of Operational Events

Mr. Donnie Bielak, PJM, reviewed PJM operations since the last OC Meeting. PJM is finalizing the analysis from the cold weather period and will share more details when the Winter Weather report is issued in the next few weeks.

### 5. Review of Operating Metrics

Mr. Joe Ciabattoni, PJM, reviewed the PJM Operating Metrics slides updated with January metrics data. Metrics included PJM's load forecast error, BAAL performance, transmission / generation outage statistics, and Perfect Dispatch historical performance. Discussions were held regarding why shortage pricing didn't trigger during the cold weather event. The impact of cold weather conditions on Perfect Dispatch performance was also discussed. PJM will provide more details on these issues in the Winter Report.

### 6. Dispatcher Training Subcommittee (DTS) Charter Changes

Mr. Don Wallin, PJM, reviewed the proposed changes to the Dispatcher Training Subcommittee (DTS) charter for the inclusion of Human Performance (HP) as a regular discussion topic. Following discussion, the Operating Committee <a href="mailto:endorsed">endorsed</a> these changes by acclamation with no objections or abstentions.

#### 7. Manual 01 Changes

Ms. Bilge Derin, PJM, reviewed the proposed changes to Manual 01: Control Center and Data Exchange Requirements. The Operating Committee will be asked to endorse these changes at the next OC meeting.





### 8. Manual 03A Changes

Mr. Andy Ford, PJM, reviewed the proposed changes to Manual 3A: Energy Management System (EMS) Model Updates and Quality Assurance (QA). <u>The Operating Committee will be asked to endorse these changes at the next OC meeting.</u>

A discussion was held regarding whether the proposed changes would change existing PJM Post Contingency Local Load Relief (PCLLRW) procedures. It was explained that the proposed changes will not impact the PJM PCLLRW operating procedures. The proposed changes clarify existing manual terminology, ensure consistency between PJM manuals and update PJM internal change management processes. The Operating Committee will be asked to endorse these changes at the next OC meeting.
