- Continue education and review of current procedures for submitting, classifying (i.e. on-time, late), evaluating, approving and scheduling transmission and generation outage requests including study timelines, analytical activities (i.e. reliability studies, expected congestion studies) and adjustments to the submitted outages based on PJM's review.
- Education and review of current procedures for submitting, evaluating and approving TERM tickets for transmission equipment ratings changes and as applicable the associated outage scheduling process to effect necessary repairs equipment to return it to its prior rating.
- Review of outage planning / coordination processes required for RTEP project implementation. This effort
 will focus on projects that may require extended outages of existing facilities (e.g. transmission line rebuild
 projects).
- Review of processes for coordinating outages. This will include coordination with other transmission owners, generation owners and adjacent systems or ISOs.
- Education and review of transmission outage acceleration processes and metrics including
 - the current practice of reviewing outages that exceed 5 days and cause more than \$500K in congestion revenue inadequacy



• the existing process for planned and forced outages as well as the potential of expanding the process to include facilities that may have a reduced rating due to a material condition issue.

Code of Conduct:


