- 1. Dave Souder, PJM, called the meeting to order. Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
- 2. Molly Mooney reviewed the December 1, 2020 Planning Committee Agenda. No changes to the agenda were requested.

David Souder, PJM, reviewed the Planning Committee Charter. No changes were been made to the Planning Committee Charter. The committee endorsed the Charter with an acclamation vote of 0 objections and 1 abstention.

6. Storage As Transmission Asset Update

Michele Greening, PJM, reviewed work done at the Storage As Transmission Asset Special Planning Committee sessions. Jeffrey Goldberg, PJM, reviewed PJM's package. A draft version of associated OA language was posted with meeting materials for informational purposes. After stakeholder discussion, additional special session meetings will be scheduled to conduct a review of Operating Agreement (OA) language. The committee endorsed the SATA package at today's meeting with a vote of 91 Yes (58%), 65 No (42%), 62 Abstain. The committee voted if the SATA package was preferable to the status quo.
