

April Planning Committee Teleconference / WebEx April 6, 2021 9:00 a.m. – 11:30 a.m. EPT

Administration (9:00 – 9:30)

- Dave Souder, PJM, called the meeting to order. Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines. The committee will be using the voting application for endorsement items due to previous vote counting issues with the acclimation vote approach.
- Molly Mooney reviewed the April 6, 2021 Planning Committee Agenda. An additional update regarding next steps with the Black Start process will be shared after agenda item 3 (noted below as 3A). Alex Stern, PSEG, raised a clarifying question and PJM confirmed that the PS proposed friendly amendment would be discussed as part of agenda item 8. No other changes to the agenda were requested.
- 3. Molly Mooney reviewed the draft minutes posted for the March 9, 2021 meeting and the Planning Committee approved the minutes.
 - 3A. Mike Bryson, PJM, updated the Planning Committee on PJM's plan to move forward with a Black Start 205 FERC filing.
- 4. Dave Anders, PJM, provided an update on the voting protocols for Board elections at the May Members Committee meeting.
- 5. Molly Mooney reviewed the 2021 PC Work Plan, updating progress through the end of the first quarter and highlighting remaining items for 2021.

Endorsements (9:30 – 10:15)

- <u>CIR Problem Statement/Issue Charge</u> Jonathan Kern, PJM, reviewed a problem statement and issue charge to address the Capacity Interconnection Rights. The Capacity Interconnection Rights issue charge passed with 99% support. There were 196 Yes votes, 1 No vote, and 1 Abstention.
- 7. Interconnection Process Reform

Jason Connell, PJM, reviewed a problem statement and issue charge to address Interconnection Process Reform. The Interconnection Process Reform issue charge passed with 100% support. There were 223 Yes votes, 0 No votes, and 1 Abstention.

8. <u>Interconnection Construction Service Agreement Superseding Language and Automatic Termination</u> <u>Provision</u>

Mark Sims, PJM, reviewed a problem statement, issue charge and proposed solution to address concerns associated with the pro forma Interconnection Construction Service Agreement's (a) lack of

superseding language and (b) current automatic termination provision. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. Alex Stern, PSEG, dicussed a proposed friendly amendment which was posted with meeting materials. After stakeholder discussion, it was decided by the Chair to defer the vote. The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the May PC meeting.

Jason Connell, PJM, provided a second first read of a Problem Statement, Issue Charge and proposed solution to address new service requests deficiency review requirements. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the May PC meeting.

11. Manual 21: Rules and Procedures for Determining Generating Capability Update Jerry Bell, PJM, provided a first read of Manual 21 regarding the biennial cover to cover review. The committee will be asked to vote on the manual changes at next month's meeting.

Andrew Levitt, PJM, provided an overview of ELCC and previewed updates for Manual 20: PJM Resource Adequacy Analysis, Manual 21: Rules and Procedures for Determination of Generating Capability, and a new Manual 21A: Determination of Accredited UCAP Using Effective Load Carrying Capability Analysis. These manual updates were provided to the PC as informational only as the CCSTF under the MRC is responsible for developing manual updates associated with ELCC.

- 13. Reliability Compliance Update Becky Davis, PJM, provided an update on the activities, issues and items of interest at NERC, SERC, and RF.
- 14. Posting Timeline Trial Period Michele Greening, PJM, reviewed information related to a proposed posting timeline trial period.
- 15. Emerging Technologies Forum Survey Natalie Tacka, PJM, provided an informational announcement about a forthcoming stakeholder survey related to emerging technologies.
