Administration (1:00-1:30)

 Jim Gluck and Molly Mooney provided a welcome, announcements, and reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation, and the Webex Participant Identification Requirements.

4. Uniform Cure Periods (1:30 – 1:40)

Steve Pincus, PJM, reviewed a Problem Statement, Issue Charge and proposed solution to address making cure periods uniform across the Tariff and Operating Agreement. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. The committee approved the issue charge and endorsed the proposed solution for the Uniform Cure Periods as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 with 100% support. There were 93 Yes votes, 0 No vote, and 14 Abstain. The committee voted if the proposed solution was preferable to the status quo. This vote passed with 100% support - 84 Yes, 0 No, and 13 Abstain.

5. Working Credit Limit Definitions (1:40 – 1:50)

Jess Troiano, PJM, reviewed a Problem Statement, Issue Charge and proposed solution to address aligning the definitions of working credit limits across the Tariff and Operating Agreement. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. The committee approved the issue charge and endorsed the proposed solution for the Working Credit Limit Definitions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 with 84% support. There were 84 Yes votes, 16 No vote, and 12 Abstain. The committee voted if the proposed solution was preferable to the status quo. This vote passed with 85% support - 93 Yes, 16 No, and 13 Abstain.
