#### Antitrust, Code of Conduct and WebEx Instructions

#### Antitrust:

If any of these items are discussed the chair will re-direct the conversation. If the conversation still persists, parties will be asked to leave the meeting or the meeting will be adjourned.

#### Code of Conduct:
