# 1. ADMINISTRATION

The Subcommittee approved the minutes of the March 4, 2014 meeting by acclamation with no objections and no abstentions.

## 2. FTR ISSUE CHARGE

Hal Loomis of PJM presented examples of how the undiversified credit adder is applied when calculating FTR credit requirements. Mr. Loomis also presented the FTR Issue Charge which was accepted without any objections or abstentions. PJM will move forward with the analysis.

## 3. VARIOUS ISSUES UPDATE

Mr. Loomis provided updates on the following issues:



- a. BLI Transfers (all transfers backed out for credit purposes) Will take effect April 15. This date was chosen to coincide with the April semi-annual PMA reset which will minimize credit impact.
- b. Virtual Credit Data Enhancement Mr. Loomis said PJM is moving forward on improving the timeliness of the data available to eCredit for current exposure calculations.
- c. Credit Available for Virtual Transactions (FERC filing to correct and clarify Tariff language)
- d. CTS/Export Credit Endorsed by the MC and will be filed soon
- e. QTU Credit Open discussion item at the MIC

## 4. LOAD REALLOCATION PROCESS

Ms. Daugherty said this issue is being discussed at the MIC. She presented draft changes to Manual 33 to clarify processes when LSEs are in default..

### 5. DEMAND BID SCREENING

Ms. Daugherty presented a historical analysis on demand bids and discussed possible screening metrics. Significant discussions ensued on possible demand bid volume limits that could be utilized.

### 6. MEMBER SURVEY

Ms. Daugherty went over the topics which will be appearing on the credit survey.
