- 2. Hamad Ahmed, secretary, reviewed the meeting participation guidelines.

- 3. Utilities will provide feedback on the PJM straw proposal in the areas of Interconnection plus registration and Planning.
 - Michele Bair, AEP, briefly discussed several topics within the PJM strawman proposal related to interconnections and registration. Michele also reviewed two distinct parallel processes for DERA registration i.e. market participation and State interconnection.
 - Ryan Dolan, Dayton Power & Light Company, discussed the utilities response to the PJM strawman proposal related to planning, highlighting several potential requirements regarding modeling of DER resources. Ryan also reviewed five distinct categories of DER resources for modeling purposes: Invertor-based Resources (IV-B), Non-Invertor based Resources (NIV-B), Battery Energy Storage System (BESS) and Relocatable Storage – Electric Vehicles (RS-EV).
 - Ryan also discussed DERA Market Registration Inputs and DERA Market Registration EDC/DO Outputs and reviewed an example of Pnode/Enode transmission planning model representation.
