TC2 Reminders - Study Deposits

 PJM will be sending emails to each developer letting them know how much they owe for the start of TC2. These emails will be going out shortly to the main contact we have on file.

 PJM's calculation will be the study deposit due minus the remaining balance from the initial deposit.

- Single deposit for entire Cycle, based on project size
- 10% is non-refundable.
- Non-binding, developer must pay full cost of study.
- Based on greater of MW energy or MW CIR

Project Size	Study Deposit
0-20 MW	\$75,000
>20-50 MW	\$200,000
>50-100 MW	\$250,000
>100-250 MW	\$300,000
>250-750 MW	\$350,000
>750 MW	\$400,000



Includes AG2 and AH1 Queues

All active AG2 and AH1 projects must reapply under new rules.

Application Deadline announced at beginning of Phase 2 of Transition Cycle #1 and corresponds to the close of Phase 2 of Transition Cycle #1.

To Be Provided by Application Deadline

- Executed Application and Studies Agreement (ASA)
- Study Deposit
- Readiness Deposit

- Site Control
- Technical information as requested by PJM data submission tool

Changes at Re-Application:

- Fuel cannot change.
- MFO/CIR cannot increase but can be reduced up to 100%.
- Developer must choose between primary or secondary POI.
