1. MSRS Basic Authentication and SUMA Updates

Mr. Nick DiSciullo, PJM, discussed the upcoming MSRS Basic Authentication updates and SUMA implementation. The subcommittee reviewed the results from the recent Report Sorting poll. Sorting will be removed from all 5-minute interval reports and some additional large data reports. The MSRS Report Dictionary will be updated to display whether a report will be sorted by PJM prior to downloading.

Mr. Sean Flamm presented the new CSV and XML formats for Billing Statement Files for use with SUMA.
