Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct and Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the December 13, 2018 MSS meeting.

Members were asked to provide any updates to their NSPL scaling plans. No updates were provided.

Working Issues

1. Energy Storage Regulation Settlement

Ms. Danielle Croop, PJM, discussed the Energy Storage Regulation Settlement filing and implementation. PJM has identified 16 resources impacted in the settlement agreement, which would be effective for 42 months after FERC approval. Additional settlement information will be provided after PJM submits the FERC filing, currently targeted for the end of February.

2. Transmission Enhancement Zonal Charge Rate

Mr. Ray Fernandez, PJM, presented a new tab on the posted Transmission Enhancement Worksheets which will display the Zonal TEC Charge Rates per MW on a monthly and annual basis.

3. MSRS Basic Authentication Updates

Mr. Nick DiSciullo, PJM, discussed the recent MSRS Basic Authentication change, which was released to the Production environment on January 24th. MSRS has been running in “Compatibility Mode” which will be removed on March 13th. Only Basic Authentication browserless requests will be valid after Compatibility Mode is removed.
