PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the November 18, 2020 MSS meeting. The Subcommittee was also reminded of the upcoming December holiday deadline extensions to Power Meter and InSchedule submissions and reviewed the proposed holiday deadline extensions for the 2021 calendar year.

Working Issues

1. 2021 December Holiday Extensions

John McComb, PJM, discussed the December 2021 Holiday timeline. Based on feedback from the proposed schedule at the November 2020 MSS meeting, John explained why it was not possible for PJM to allow submission holidays for both December 23rd 2021 and December 27th 2021. Options were presented for resolution, and stakeholder representatives were asked to relay the options internally with the goal of Subcommittee consensus at a future meeting in 2021.

2. FERC EQR Updates for Fast Start

Sean Flamm, PJM, presented proposed updates to PJM's FERC EQR in relation to settlement updates for Fast Start.

3. MSRS Refresh Project

Sean Flamm discussed the status of the MSRS refresh project and reminded the Subcommittee of the release of the refreshed MSRS UI to the Train environment. Sean also detailed the project timeline as it extends into 2021.
