- PJM Settlements group is currently working to reorganize and redesign the layout of Billing, Settlements & Credit section and subpages.
- Survey was distributed through MSS email list.

### How would you rate the ability to find information you are looking for?

- 79% percent of 33 responses gathered as of slide creation said information was overall easy to find.
  - Section contains a lot of helpful information.
  - If experienced and know where to look, information is easy to retrieve.
- However, a few responses indicated that information was somewhat or extremely difficult to find.
  - The main Billing, Settlements & Credit section page contains a lot of information to sift through.
  - Sometimes difficult to determine where certain information is stored.
  - Links to various documents or pages are scattered on certain pages and could be better organized.

## Specific Feedback/Improvements

- Include roadmap for changes to section pages.
- A few comments detailed expandability of categories on MSRS Reports
  Documentation page and difficulty of knowing where to look for specific
  report documentation.
  - Updates released late October 2021 to MSRS Reports Documentation page include always expanded report categories and removal of duplicate 5 minute report documentation. Allows for quick search (Control + F) of documentation on page.
- Ease of use from mobile devices.
  - Topic is out of scope from Settlement team design perspective, but will pass on any similar comments and suggestions to PJM web development team.
