Reliability Standards and Compliance Subcommittee Webex/Conference Call June 11, 2021 9:00 a.m. – 10:00 a.m. EPT

### Administration (9:00-9:15)

- 1. Monica Burkett, PJM, welcomed the group and announced that Manual 3 and 36 have been endorsed and that the 2021 Gen Model Window is open until June 15.
  - A. Laura Walter and Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, and Webex Participant Identification Requirements.
  - B. They also indicated that a Webex report will be used to capture meeting attendance
  - C. Laura Walter reviewed the agenda for the meeting. The agenda was approved with no objections and no abstentions.
  - D. Monica Burkett reviewed <u>minutes</u> from the May 21, 2021, RSCS meeting. The minutes were approved with no objections and no abstentions.
- 2. Monica Burkett discussed an upcoming survey for RSCS members on ways to improve content formatting and logistics of the RSCS that will be sent out by June 18, 2021.

### PJM Compliance Activities (9:15-9:35)

- 3. Manual Updates
  - A. Rebecca Carroll, PJM, provided a review of updates to Manual 13: Emergency Operations. Some additional revisions will be incorporated when presented at the MRC. SOS will be defined as well as all the variants (SOS-G, SOS-T, SOS-J, etc). Section 6 Attachment J will be updated as DOE made changes to OE-417 is now DOE-417 and the table will be revised for the updated form. These changes will be going to the MRC at the end of this month and returning to the RSCS for an informational update in July.
- 4. Gizella Mali, PJM, discussed an update on Notification of Critical Assets related to IROL Calculations, CIP-002, and CIP-014 Annual Letter. The determination of Critical Assets is CEII.
- 5. Vince Stefanowicz, PJM, presented the development of a <u>planned survey</u> related to the Generating Facility Cold Weather Operating Limits. He indicated that renewable generation operators and any generator operator that has not previously responded to the 2019 GO survey will be asked to fill out this periodic survey via eDART and this survey is focused on low ambient operating temperature limits. Vince mentioned that the survey will be open from June 14 to August 14, 2021.

### FERC, NERC, and Regional Activities (9:35-9:55)

- 6. Becky Davis, PJM, provided an update on FERC, NERC and regional activities.
  - Becky updated the subcommittee on NERC periodic review projects, an upcoming NERC Inverter-Based Resource Performance Working Group Webinar
