## Administration (9:00-9:15)

- 1. Welcome and Announcements
  - A. Ashwini Bhat and Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, and Webex Participant Identification Requirements.
  - B. They also indicated that a Webex report will be used to capture meeting attendance
  - C. Ashwini Bhat reviewed the agenda for the meeting. The agenda was approved with no objections and no abstentions.
  - D. Monica Burkett reviewed minutes from the February 18, 2021, RSCS meeting. The minutes were approved with no objections and no abstentions.
- 2. Monica Burkett, PJM, reviewed the action items related to the survey feedback received in July, 2021. She discussed the survey summary indicating very high positive open ended responses from about 16 companies. Monica also discussed several categories like Continual Learning, Notifications, Standards/Manuals, Compliance Updates, Ballots etc. with the RSCS group. She thanked all the stakeholders for all the feedback and asked them to email us if there were any updates that could help improve the experience at RSCS.

## PJM Compliance Activities (9:15-9:35)

- 3. Manual Updates
  - A. Bilge Derin, PJM, provided a manual update on Manual 1. As part of the periodic review she discussed minor changes through the manual . Bilge also discussed additional changes due to NERC and CIP standards which included CIP-012, COM-001, EOP-008. She also indicated the timeline for first reads and endorsements. The first read at MRC is on March 23 and will be effective at MRC on April 27. For more details refer to the presentation on Manual 1.

# FERC, NERC, and Regional Activities (9:35-9:55)

- 4. Bilge Derin, PJM, provided an informational update regarding PJM's FERC Order No. 881 compliance efforts relating to ambient adjusted ratings. She discussed Order No. 881 areas of reform, potential options for consideration which included Centralized, Distributed, Hybrid for rating approaches and minimum requirements. Bilge indicated that PJM will be reaching out to Transmission owners to get alignment on compliance approach in regard to FERC Order 881. She also discussed the time line for PJM compliance filing and mentioned that the deadline for filing is on July 12. For more information, refer to the presentation.
