1. Welcome and Announcements

Monica Burkett, PJM, informed the group that a communication was sent for actions required on the NERC Reliability standard TPL-001-5 by Friday, August 5. She also reminded the group that the PJM team is reviewing best practices and will be reaching out to a few attendees for presenting at the September RSCS meeting.

- A. Ashwini Bhat and Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, and Webex Participant Identification Requirements.

- 3. Stanley Sliwa, PJM, provided an overview of the criteria to establish acceptable system steady state voltage performance during a GMD event per TPL-007-4 Requirement R3. He discussed the steady state voltage criteria established pursuant to PJM Manual 03, 14B, and 39 along with steady sate voltage performance stages 1 (Initial Condition), stage 2 (GMD Event) and stage 3 (GMD Event with Outages). - 4. Michael Herman, PJM, provided an update regarding the upcoming language change in FAC-003-5. He discussed PJM's initial thoughts, regarding the implementation of FAC-003-5 in planning analysis, based on an updated version of this standard. Michael also mentioned that PJM intends to come to RSCS with documentation and exact process and also request Facility Owners to provide this information, mostly in October time and request for feedback.
