- 1. The agenda for this meeting was approved without comment.
- 2. The draft minutes from the March 9, 2020 SOS Joint Meeting were approved without comment.



Review of Operations (9:05-9:10)

3. Ms. Carroll provided an update of System Operations in March PJM and its members experienced 1 Synchronized Reserve Event, 1 Shared Reserve Event, 4 High System Voltage Actions and 3 PCLLRWs were issues. PJM will begin sequestering dispatchers as of Saturday, 4/11. The dispatchers were sequestered proactively and they will be isolated to one of PJM's three control rooms.

eDART Updates (9:10-9:15)

- 4. Ms. Ofoegbu provided an update on the latest and upcoming eDART release.
 - a. eDART Tech Forum held a meeting in March.
 - b. The eDART release on March 18 included an enhancement to change user inputted unprintable characters to an asterix (*). The unprintable characters were causing issues for applications downstream of eDART.
 - c. Next eDART release will occur on May 19, the training environment version available on May 6.
 - d. Another eDART Tech Forum meeting is scheduled for May 6.

Code of Conduct:


