Administration

Package Discussion

Package sponsors provided reviews of, and updates to, their respective proposals. Prior to these reviews, it was noted that both ODEC and the Capacity Choice proposals were withdrawn from consideration based on feedback received from the poll results, as well as offline conversations.

Additionally, Mr. Stu Bresler commented on the work of the CCPPSTF as it relates to, or may be impacted by the DOE proposal to FERC. He noted that PJM's Board of Manager's believes that the work conducted by the Capacity Construct/Public Policy Senior Task Force is valuable and that the Board believes the stakeholders involved in this group should continue that work to come to consensus on a proposed solution.

Mr. Anders noted that the group will continue on the current course of action to review packages and work towards consensus. Packages sponsors will have the opportunity to review any updates to their current proposals at the next meeting of the CCPPSTF on November 1.
