### **CBIR**

  - a. Andrew Levitt, PJM, discussed proposed detailed definitions of the design components, as well as any applicable descriptions of the status quo. Andrew also provided a brief update on the status of proposed design components in the parking lot (i.e., one regarding Capacity Interconnection Rights and another regarding Capacity Performance assessment).
