



**DRAFT MEETING MINUTES**

**1. Administration**

- a. Mr. Dave Anders opened the meeting with a review of the progress made to-date and the agenda for the meeting. Mr. Anders made mention that the Actions Items were to be reviewed after the lunch break, since they all relate to the Phase 1 discussions. Phase 2 discussions were to be held in the morning session.
- b. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes. Minutes were approved and will be posted as final.

**2. Phase II Interest Identification**

Mr. Anders briefly described the purpose of the interest identification and highlighted the goal of the exercise. The matrix was pre-populated with interests taken directly from the MRC approved problem statement. Stakeholders provided additional interests which were documented in the matrix.

**3. Design Component Development**

The design components tab was pre-populated with components that PJM felt encompassed the high level aspects of allocation. The matrix was also pre-populated with a list of transactions and the associated status quo allocation calculations presented by Monitoring Analytics. Components surrounding marginal loss surplus and FTR surplus/balancing congestion were added to the list of transactions since it was confirmed that the charter does not explicitly exclude these transactions. It was requested that the design components be grouped together to allow for better understanding and ease of use.

**4. Review of Open Action Items**

Mr. Anders reviewed the list of open action items. Ms. Suzanne Coyne presented available information concerning allocation. Mr. Adam Keech updated PJM's Phase I proposal package executive summary to address several items. Other items were discussed during Phase I matrix proposal review.

**5. Review new proposals for Phase I Matrix**

- a. Mr. Keech reviewed the changes to PJM's matrix and the sections where PJM and the MMU were able to come to a consensus.
- b. Mr. Barry Trayers presented his proposal with an additional component addressing the unit commitment process.

**6. Review Open Action Items and Future Agenda Items**

Ms. Velasco reviewed the new action items taken from the meeting. Mr. Anders mentioned that Phase I and Phase II will need to be worked on in conjunction as opposed to pushing a proposal through for Phase I before working



through Phase II. The design components for each phase are highly dependent on each other and working through them individually is not optimal. Future meetings will reflect this new approach.
