1. Administration

- a. Mr. Anders opened the meeting and reviewed the agenda.
- b. Mr. Callis performed roll call, reviewed the draft meeting minutes and the meeting guidelines. Minutes were approved and will be posted as final.

2. Review Poll Results

Mr. Anders reviewed the results of the poll, dated, September 12. The poll was designed to allow stakeholders to voice their preference for how to proceed in light of the FERC order on UTCs. The results of the poll indicated that 42% of respondents prefer to maintain our current schedule with an additional 21% preferring to expedite our schedule. Therefore the EMUSTF will not attempt to separately develop cost allocation proposals related to virtual transactions at this time; rather the EMUSTF will continue with development of comprehensive cost allocation proposals.

3. Review Phase 2 Allocation Poll Questions

Stakeholders discussed the phase 2 allocation poll questions and made adjustments. Per Mr. Anders, the phase 2 allocation poll will be sent to stakeholders as soon as possible. The goal is to present the final results at the October 16 EMUSTF meeting.
