The committee voted if the proposed solution was preferable to the status quo. This vote passed with approximately 100% support - 275 Yes, 1 No, and 0 Abstain.

Transition to New Process

Planning Committee: The committee endorsed the PJM transition package with approximately 91% support. There were 218 Yes votes, 22 No votes, and 14 Abstain. The transition package proposed by National Grid Renewables failed with 3% support. There were 6 Yes votes, 200 No votes, and 48 Abstain. The alternate transition package proposed by Bitter Ridge Wind Farm LLC, Tri Global Energy, Hecate Energy, and Leeward Energy also failed with 34% support. There were 69 Yes votes, 134 No votes, and 51 Abstain.

Markets & Reliability Committee: The PJM transition package was the main motion. Following discussion, the main motion was approved and the associated Tariff revisions were endorsed in a sector-weighted vote with 4.368 in favor.
