Modeling Generation Senior Task Force (MGSTF) PJM Conference and Training Center and WebEx January 7, 2019 1:00 – 2:38 p.m. EPT

### Administration

Mr. Stanley Williams and Ms. Megan McLaverty, PJM, welcomed, reviewed PJM meeting guidelines, agenda, and completed the roll call.

Ms. McLaverty asked the MGSTF to approve meeting minutes from the August 7, 2018 meeting. The minutes were approved as written without any objections or abstentions.

## **Solution Options Matrix and Timeline**

Mr. Stan Williams, PJM, provided an update on the implementation timeline and sought directional input from stakeholders. Stakeholders confirmed their desire to continue the development of potential short term solutions which may be implemented near-term until an enhanced model can be fully developed. Stakeholders also expressed their interest in testing and providing input during the development of new software for the enhanced model.

Mr. Stan Williams reviewed the document containing a summary of feedback received to date from stakeholders regarding design component prioritization. Additional stakeholder feedback will be added to the existing document for review at the February MGSTF.

Mr. Tom Hauske, PJM, discussed potential short-term items for stakeholder consideration.
