## 3. INTERCONNECTION PLANNING AND METERING – EDUCATION SESSION #1 (2.5 HOURS)

- b. Mr. Ken Graff will provide a presentation of PJM's current Planning Processes. Ensuing dialog will permit the capture of potential implications of NEM to Planning.
- c. Ms. Priscilla Chandler will outline efforts to document current and pending legislative and regulatory practices regarding NEM with the expectation that the deliverable will serve as an ongoing resource to the task force.
- d. Mr. Dessender will lead a review of current metering standards and requirements. Dialog will enable capture of any potential metering issues once we conclude the education sessions.
