## Administration

1. Lisa Morelli, facilitator, and Amanda Egan secretary, welcomed participants, made announcements and reviewed the Anti-trust, Code of Conduct, and Media Participation Guidelines.

## Education and CBIR


2. Lauren Strella Wahba, PJM, provided information on the temporary exception process and its use in adjusting hourly notification times to reflect fuel procurement constraints.
3. Joe Ciabattoni, PJM, reviewed a proposal to allow hourly notification times to be considered when clearing the Day-Ahead Energy Market. Approval from the task force to treat this presentation as a first read will be sought.
4. Lisa Morelli, PJM, led a discussion on voting timelines that would allow the hourly notification time proposal to be implemented in advance of this coming winter. The task force decided to vote on the proposal following the September 2024 RCSTF meeting.

## MRC Follow-Up

5. Lisa Morelli, PJM, reviewed the results of the July MRC vote on the RCSTF reserve deployment and reserve requirements proposals and discussed next steps.

## Future Agenda Items

6. Lisa Morelli, PJM, led a discussion on the path forward for the RCSTF. The task force decided to pivot to begin work on the long-term solution scope. Education sessions addressing the long-term scope will be held in October and November.
