Danielle Croop and Risa Holland provided welcome, announcements, introductions, and review of the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines.

- Danielle Croop reviewed the Reactive Power Compensation Task Force agenda for today's meeting.

#### Code of Conduct:


