1. Ms. Rebecca Carroll, PJM, and Ms. Susan Kenney, PJM, provided administrative updates, performed roll call, and reviewed the Anti-trust, Code of Conduct, and Public Meetings/Media Participation Guidelines.
2. Minutes from the August 17, 2016 Underperformance Risk Management Senior Task Force meeting were approved with 0 objections and 0 abstentions.
3. Ms. Rebecca Stadelmeyer, PJM, provided an update to the group regarding the timing of the calculation of the Final Balancing Ratio and the issuance of the PJM Invoice. PJM agrees it can post the Balancing Ratio that will be used in the initial settlement of the subject Performance Assessment Hour at least four business days prior to the end of the month in the event a package is approved that allows a retroactive replacement to be submitted up to three business days after the posting of such Balancing Ratio.

5. Ms. Carroll reviewed polling questions and took suggestions from stakeholders on the questions and format of the poll.
