ANSWER OF PJM INTERCONNECTION, L.L.C.

Pursuant to Rules 212 and 213 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission’s (“Commission”),¹ and the Commission’s April 17, 2019 Notice of Complaint,² PJM Interconnection, L.L.C. (“PJM”) submits this Answer in response to the December 23, 2019 motion for extension of time, request for shortened comment period, and request for expedited action (“Motion”) of American Electric Power Service Corporation (“AEPSC”), on behalf of its affiliates Appalachian Power Company, Indiana Michigan Power Company, Kentucky Power Company, Kingsport Power Company, Ohio Power Company, Wheeling Power Company and AEP Energy Partners, Inc.; East Kentucky Power Cooperative, Inc. (“EKPC”); and NextEra Energy Resources, LLC (“NextEra Resources”) (together, “Movants”).

The Movants requests that the Commission extend the deadline for submitting interventions, protests, and comments in the above captioned docket by ten days to Monday, January 13, 2020. Additionally, Movants request a shortened comment period and an order granting this motion by December 30, 2019, as the due date for comments is currently January 2, 2020.
