ORDER ADOPTING REVISED PROCEDURAL SCHEDULE

(Issued April 25, 2024)

- 1. On April 16, 2024, the Chief Administrative Law Judge (Chief Judge) issued an order adopting new hearing commencement and initial decision deadlines for this proceeding and directing me to adopt a procedural schedule consistent with his order.¹
- 2. On April 17, 2024, I issued an order scheduling a prehearing conference for April 24, 2024, to discuss a revised procedural schedule as well as other issues to resume the evidentiary hearing.² At the conference, a subset of the participants proposed a new procedural schedule, and after some discussion, all participants agreed on the attached schedule. I find that the attached schedule has broad support among the participants, complies with the dates set out by the Chief Judge, and does not otherwise interfere with the development of an adequate record. Accordingly, I ADOPT the attached schedule as the procedural schedule for the remainder of this proceeding.
