Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act ("FPA")¹ and Part 35 of the Federal Energy Regulatory Commission's ("Commission") Regulations,² PJM Interconnection, L.L.C. ("PJM") hereby submits for filing the following proposed revisions to the PJM Open Access Transmission Tariff ("Tariff") and the PJM Consolidated Transmission Owners Agreement ("CTOA"):

- i. Revised Tariff, Attachment L revised to reflect the name change of Essential Power Rock Springs, LLC ("Essential Power") as a PJM Transmission Owner; and
- ii. Revised CTOA, Attachment A revised to reflect the name change of Essential Power as a PJM Transmission Owner, and signature page to the CTOA, executed by Jason Solimini of Essential Power.³

PJM submits this filing to reflect a correction of a previous name change that was inadvertently omitted from the Tariff, Attachment L and CTOA, Attachment A. PJM requests an effective date of December 29, 2019, for the revisions to the Tariff and CTOA sections proposed in this filing.

I. BACKGROUND

On February 24, 2005, CED Rock Springs, LLC ("CEDRS") became a member of PJM.⁴ Since that time, CEDRS changed its name to: (i) NAEA Rock Springs, LLC ("NAEA") on May 8, 2008;⁵ (ii) EP Rock Springs, LLC on January 1, 2012;⁶ and (iii) Essential Power Rock Springs, LLC as of March 5, 2013.⁷ While some of the name changes were reflected in the Tariff and CTOA, the final change to Essential Power Rock Springs, LLC was inadvertently omitted from various sections of the Tariff and CTOA. PJM submits this filing to cure these omissions.

II. PROPOSED REVISIONS

A. Tariff, Attachment L

PJM proposes to revise the list of transmission owners in Tariff, Attachment L to replace Essential Power's previous name (i.e., NAEA) with its currently-effective corporate name, which is Essential Power Rock Springs, LLC.

B. CTOA, Attachment A

PJM submits a revised CTOA, Attachment A to reflect Essential Power's name change from CEDRS to its current name, Essential Power Rock Springs, LLC, in the list of PJM Transmission Owners. Additionally, PJM submits a revised, executed signature page to the CTOA for Essential Power.

III. EFFECTIVE DATE AND WAIVER

PJM requests an effective date no later than December 29, 2019 for the attached PJM Tariff and CTOA sections, which date is at least sixty (60) days after the date of this filing.
