RE: Effective Date of PJM Transmission Owners' Tariff Revisions to Conform to

Effective Date of PJM's Interconnection Queue Tariff Reforms

Docket No. ER22-2114-001

Dear Secretary Bose:

Pursuant to Part 35 of the Federal Energy Regulatory Commission's ("Commission") regulations¹ and Section 9.1(a) of the PJM Interconnection, L.L.C. ("PJM") Open Access Transmission Tariff ("PJM Tariff"), the PJM Transmission Owners,² acting through the PJM Consolidated Transmission Owners Agreement ("CTOA"), notify the Commission that Part VIII, Subpart 1, section 436 of the PJM Tariff will become effective on October 5, 2023.³

I. BACKGROUND

In 2021, in Docket No. ER21-2282, the PJM Transmission Owners submitted proposed revisions to the PJM Tariff to provide them with the ability to elect to fund Network Upgrades associated with the interconnection of new generation resources and to earn a return of and a return on the costs of those upgrades. The Commission accepted and suspended the filing

effective February 1, 2022 subject to the outcome of a paper hearing process.⁴ On June 14, 2022, PJM proposed a comprehensive package of reforms to the PJM interconnection process contained in the PJM Tariff, including new Parts VII, VIII (covering New Rules), and IX.⁵ The proposed changes necessitated conforming changes to the tariff provisions governing the PJM Transmission Owners' ability to elect to fund Network Upgrades. The PJM Transmission Owners proposed those conforming changes through a filing in this docket on June 14, 2022.⁶

In conformance with the effective dates PJM requested, the PJM Transmission Owners requested an effective date of January 3, 2023 for the proposed revisions to Parts VII and IX and 12/31/9998 as to Part VIII. The Commission later accepted PJM's revisions subject to condition.⁷ The Commission also accepted and suspended the PJM Transmission Owners' conforming revisions, with the Part VIII revisions to be effective 12/31/9998 as requested, subject to refund and the outcome of the Docket No. ER21-2282 proceeding.⁸

On September 5, 2023, PJM notified the Commission that Part VIII will become effective as of October 5, 2023.9

II. THIS FILING

To conform to PJM's effective date—and as anticipated by the PJM Transmission Owners' June 2022 Filing and recognized in the December 2022 Order—the PJM Transmission Owners request to change the requested effective date for the proposed Tariff revisions to Part VIII from "12/31/9998" to October 5, 2023.

Pursuant to 18 C.F.R. § 35.17(d), there is good cause for the Commission to accept this effective date in conformance with PJM's effective date.¹⁰ The PJM Transmission Owners notified parties in their original filing that they intended their conforming revisions to Part VIII to have the same effective date of the changes proposed by PJM.¹¹ Allowing these revisions to have the same effective date as PJM's effective date will allow the PJM Transmission Owners'

revisions to conform to the corresponding revisions of PJM to its interconnection process. Aligning the effective date of the PJM revisions and the PJM Transmission Owners' proposed revisions is the most reasonable and efficient manner of incorporating both sets of changes. Misaligned dates could jeopardize the objectives of both sets of revisions. The Commission has previously found good cause to allow revisions to suspended tariffs under § 35.17(d) where it found separate tariff revisions "should have the same effective date" in order "to avoid inconsistencies between" the tariffs. Because the PJM Transmission Owners have given clear notice of their intent to align those dates, no party will be prejudiced by the requested effective date and there is good cause to grant the request. The PJM Transmission Owners also do not propose to change rates, terms or conditions of service under the previously accepted provision of the PJM Tariff that are affected by this filing.

The PJM Transmission Owners request the Commission grant any and all waivers of its rules and regulations as necessary for the Commission to accept the effective date proposed by the PJM Transmission Owners for revisions to the PJM Tariff, specifically including but not limited to 18 C.F.R. § 35.3(a)(1).¹⁵

III. SERVICE

PJM has served a copy of this filing on all PJM Members and on all state utility regulatory commissions in the PJM Region by posting this filing electronically. In accordance with the Commission's regulations, ¹⁶ PJM will post a copy of this filing to the FERC filings section of its internet site, located at the following link: https://pjm.com/library/filing-order.aspx with a specific link to the newly-filed document, and will send an e-mail on the same date as this filing to all PJM Members and all state utility regulatory commissions in the PJM Region alerting them that this filing has been made by PJM and is available by following such link. If the document is not immediately available by using the referenced link, the document will be available through the referenced link within 24 hours of the filing.
