On January 31, 2019, PJM Interconnection, L.L.C. (PJM) filed revisions to the Amended and Restated Operating Agreement of PJM Interconnection, L.L.C., Schedule 12, and the Reliability Assurance Agreement among Load Serving Entities in the PJM Region (RAA), Schedule 17, to update these lists to include new members, remove withdrawn members, reflect the signatories to the RAA, and reflect corporate name changes for the fourth quarter of 2018 beginning October 1, 2018, and ending December 31, 2018.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective December 31, 2018, as requested.

The filing was noticed on January 31, 2019, with comments, interventions, and protests due on or before February 21, 2019. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2018)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
