Dear Secretary Bose:

On December 1, 2014, PJM Interconnection, L.L.C. (“PJM”) submitted for filing revisions to the PJM Open Access Transmission Tariff (“PJM Tariff”) to comply with the Final Rule issued on September 18, 2014, by the Federal Energy Regulatory Commission (“FERC” or the “Commission”) in Docket No. RM05-5-022 (“Final Rule” or “Order No. 676-H”).¹

This errata filing serves to correct several typographical errors discovered in the proposed Tariff revisions submitted along with PJM’s filing. In particular, PJM’s proposed Tariff revisions should be revised as follows:

- In the first sub-paragraph of section 4.2, relating to WEQ-000, the words “inconsistent,” “Transmission,” “procedures,” and “Definition” have been corrected;
- In the second sub-paragraph of section 4.2, relating to WEQ-001, the word “Transmission” in the first line and the word “Transmission” in the 10th line has been corrected. Additionally, in the same sub-paragraph, 9th line, the word “not” has been added to the phrase “...to the extent *not* inconsistent with...” (emphasis supplied);

- In the 11th sub-paragraph of section 4.2, relating to WEQ-012, the phrase “(with Final Actions ratified on October 4, 2012),” has been added at the end of the sentence, and;
- In the 14th sub-paragraph of section 4.2, a space has been added between the words “WEQ” and “Version” in the final line.
