Amendment to Extend Time for Action

Dear Ms. Bose:

PJM Interconnection, L.L.C. (“PJM”) hereby submits a non-substantive amendment to its pending tariff change filing in this proceeding, solely for the purpose of extending the time for Commission action, and thereby accommodating stakeholders’ desire for a lengthened comment period on PJM’s original filing (“October 12 Filing”). ***To that end, PJM asks the Commission’s Secretary to issue a new notice establishing November 19, 2018, as the deadline for comments in this proceeding.***¹

On October 12, 2018, PJM submitted for filing in this proceeding revisions to the PJM Open Access Transmission Tariff (“Tariff”) to revise certain Reliability Pricing Model auction parameters that PJM is required by its Tariff to review every four years through an analysis and stakeholder process. PJM originally requested an effective date of December 12, 2018, for the October 12 Filing. The Commission on October 15, 2018, issued its notice of the filing, setting November 2, 2018, as the deadline for interventions, comments, and protests.

Certain PJM stakeholders have sought PJM’s reaction to a proposed two-week extension in the comment deadline. PJM is willing to support such an extension, but is concerned that the later comment deadline could hamper the Commission’s efforts to prepare a fully-informed order on the October 12 Filing by December 12, 2018. To resolve that potential conflict, PJM submits today a non-substantive amendment with a new proposed effective date of January 17, 2019. PJM is making no change to the Tariff revisions proposed in the October 12 Filing; only the effective date is being changed. Specifically, PJM is resubmitting all Tariff records that accompanied the October 12

Filing, with a metadata effective date of January 17, 2019, to replace the metadata effective date of December 12, 2018.

PJM notes that under the Commission's twenty-one day standard, comments on today's filing would typically be due by November 16, 2018. As stated above, PJM asks that the Secretary instead establish November 19, 2018, as the deadline for comments in this proceeding.

PJM has served a copy of this filing on all PJM members and on all state utility regulatory commissions in the PJM Region by posting this filing electronically. In accordance with the Commission's regulations,² PJM will post a copy of this filing to the FERC filings section of its internet site, located at the following link: <http://www.pjm.com/documents/ferc-manuals/ferc-filings.aspx> with a specific link to the newly-filed document, and will send an e-mail on the same date as this filing to all PJM members and all state utility regulatory commissions in the PJM Region³ alerting them that this filing has been made by PJM and is available by following such link. PJM also serves the parties listed on the Commission's official service list for this docket. If the document is not immediately available by using the referenced link, the document will be available through the referenced link within 24 hours of the filing. Also, a copy of this filing will be available on the FERC's eLibrary website located at the following link: <http://www.ferc.gov/docs-filing/elibrary.asp> in accordance with the Commission's regulations and Order No. 714.
