Proposed Tariff Amendments for Replacement Generation Interconnection Service,
Request to Change Requested Effective Date

Dear Secretary Reese:

On October 31, 2025, PJM Interconnection, L.L.C. (“PJM”) filed with the Federal Energy Regulatory Commission in the referenced docket proposed amendments to Part VIII of PJM’s Open Access Transmission Tariff (“Tariff”) to establish Replacement Generation Interconnection Service as a separate serial interconnection process for the efficient and timely transfer of Capacity Interconnection Rights from deactivating generation resources to new replacement resources.¹ When made, the October 31 Filing requested an effective date 61 days after the date of filing, January 1, 2026.²

On November 21, 2025, Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor (“IMM”) for PJM submitted comments responding to the October 31 Filing.³ The IMM Comments raise the IMM’s concerns about the October 31

Filing. Other parties filed in support of the October 31 Filing.⁴ To provide the Commission additional time to consider the IMM Comments, the comments in support of the October 31 Filing filed by others, and a PJM response to the IMM Comments, PJM respectfully requests that the effective date for the October 31 Filing be revised to January 30, 2026. To effectuate this change, PJM submits in eTariff the Tariff sections included in the October 31 Filing with the metadata revised to reflect the changed requested effective date of January 30, 2026.
