Correction to eTariff Metadata to PJM Rate Schedule 48, PJM-DOE Reliability Services  
Agreement*

Dear Secretary Reese:

Pursuant to section 205 of the Federal Power Act,<sup>1</sup> and part 35 of the Federal Energy Regulatory Commission (“Commission”) regulations,<sup>2</sup> PJM Interconnection, L.L.C. (“PJM”)<sup>3</sup> submits this filing to correct certain eTariff metadata of PJM Rate Schedule 48, PJM-DOE Reliability Services Agreement, that was previously filed and accepted in Docket No. ER18-2496-000.<sup>4</sup>

PJM submitted its December 2018 compliance filing pursuant to the Commission’s November 29, 2018 Order.<sup>5</sup> The Commission subsequently issued an order accepting PJM’s December 2018 Filing on January 25, 2019, to be effective December 1, 2018.<sup>6</sup>

PJM has since determined that due to clerical error, the eTariff metadata of eTariff Record ID 277, which is Rate Schedule 48, included incorrect information. Specifically, the Parent ID

was inadvertently entered as Code 203 (belonging to Rate Schedule 47), rather than Code 0, the PJM Rate Schedule Tariff. As a result, Rate Schedule 48 appears within the eTariff system as part of Rate Schedule 47. PJM submits this filing to correct this single administrative eTariff metadata error. This correction to the metadata does not otherwise change the previously filed and accepted Rate Schedule 48. Because the agreement was never terminated, it remains in full force and effect.

#### **I. EFFECTIVE DATE AND REQUEST FOR WAIVER, IF NECESSARY**

The Commission should accept this filing effective December 1, 2018. Allowing the updated version of Rate Schedule 48 to be effective on December 1, 2018 is appropriate because that will ensure that Rate Schedule 48 consistently and continuously reflects the correct, Commission-accepted eTariff records on the effective date granted by the Commission. Further, PJM is not proposing any new revisions to Rate Schedule 48. In the alternative, if the Commission finds a waiver is necessary, PJM requests waiver of the FPA and the Commission's 60 days' prior notice requirement<sup>7</sup> to allow the Commission to accept this ministerial correction, to be effective on December 1, 2018. Good cause exists for granting such waiver for the reasons set forth above. Accordingly, the Commission should accept this filing with the requested effective date.
