Dear Mr. Shparber:

On July 3, 2014, PJM Interconnection, L.L.C., (PJM) submitted revisions to multiple sections of the PJM Open Access Transmission Tariff, the Amended and Restated Operating Agreement of PJM, the Joint Operating Agreement between the Midwest Independent System Operator, Inc. and PJM, and the Amended and Restated Joint Operating Agreements among and between PJM and Progress Energy Carolinas in two separate filings listed above.¹ You state that the purpose of these revisions is to reflect PJM's recent change to its mailing address in the governing documents and other ministerial revisions.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittals are accepted for filing, effective September 2, 2014, as requested.

The filings were noticed on July 3, 2014, with comments, interventions, and protests due on or before July 24, 2014. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2014)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order,

such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against PJM.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
