Dear Ms. Tribulski:

On November 12, 2015, as amended on January 6, 2016,<sup>1</sup> PJM Interconnection, L.L.C. (PJM) submitted revisions to the PJM Open Access Transmission Tariff (OATT), the Amended and Restated Operating Agreement of PJM Interconnection, L.L.C. (Operating Agreement), and the PJM Reliability Assurance Agreement among Load Serving Entities in the PJM Region (RAA)<sup>2</sup> to incorporate previously accepted revisions which would otherwise not be reflected due to the overlapping timing of certain PJM filings. PJM requests effective dates of April 1, 2015, May 11, 2015, July 13, 2015 and August 3, 2015, for the proposed revisions, consistent with the effective dates originally approved for the revisions.

Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective as requested.<sup>3</sup>

The filing in Docket No. ER16-316-000 was noticed on November 13, 2015, and the subsequent filing in Docket No. ER16-316-001 was noticed on January 7, 2016, with comments, interventions and protests due on or before December 3, 2015, and January 27, 2016, respectively. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2015)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against PJM.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
