On May 9, 2019, PJM Interconnection, L.L.C. (PJM) submitted a compliance filing to correct the metadata effective date for the record submitted in Docket No. ER19-105-002 from December 12, 2018 to January 17, 2019.<sup>1</sup> PJM states that the eTariff record's metadata submitted with its February 14, 2019, Deficiency Letter Response reflected a December 12, 2018 effective date.<sup>2</sup> PJM also states that the instant filing complies with the Commission's directive to revise the metadata effective date of the Deficiency Letter Response eTariff record to January 17, 2019.<sup>3</sup>

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective January 17, 2019, as requested.

The filing was noticed on May 9, 2019, with comments, interventions, and protests due on or before May 30, 2019. None were filed. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2018)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
