On March 16, 2023, PJM Interconnection, L.L.C. (PJM) submitted revisions to section 4.2 of the PJM Open Access Transmission Tariff<sup>1</sup> in compliance with the directives in a Commission order issued on February 23, 2023<sup>2</sup> regarding the cybersecurity and parallel flow visualization related requirements of Order No. 676-J.<sup>3</sup> The revisions are in satisfactory compliance with the February Order. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, the submittal is accepted for filing, effective February 23, 2023, as requested.
