On March 8, 2023, as amended on April 27, 2023, PJM Interconnection, L.L.C. (PJM) submitted revisions to correct, clarify, and/or make consistent certain provisions of the PJM Open Access Transmission Tariff, the Amended and Restated Operating Agreement of PJM, and the Reliability Assurance Agreement Among Load Service Serving Entities in the PJM Region.¹ Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East under 18 C.F.R. § 375.307, the submittals are accepted for filing, effective May 8, 2023, as requested.

The filings were publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the applicant(s).

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
