On April 12, 2024, as amended on June 10, 2024 and August 6, 2024, PJM Interconnection, L.L.C. (PJM) submitted ministerial clean-up revisions to its Open Access Transmission Tariff (Tariff) and to the Amended and Restated Operating Agreement of PJM (Operating Agreement) to ensure that the Tariff and Operating Agreement correctly reflect language accepted by the Commission.<sup>1</sup> PJM requested that the clean-up revisions be accepted effective June 1, 2023, October 28, 2023, November 1, 2023, December 12, 2023, January 15, 2024, January 22, 2024, and March 31, 2024. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, the submittal is accepted for filing, effective June 1, 2023, October 28, 2023, November 1, 2023, December 12, 2023, January 15, 2024, January 22, 2024, and March 31, 2024, as requested.<sup>2</sup>

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission’s regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.
