Dear Aspassia Staevska:

On August 28, 2025, PJM Interconnection, L.L.C. (PJM), in accordance with Schedule 12 of the PJM Open Access Transmission Tariff (Tariff), and pursuant to section 205 of the Federal Power Act,<sup>2</sup> submitted revisions to Schedule 12-Appendix A of its Tariff to incorporate cost responsibility assignments for four baseline upgrades in the Regional Transmission Expansion Plan (RTEP), as approved by the PJM Board of Managers on July 30, 2025. PJM also filed revisions to Schedule 12-Appendix A to implement scope changes to nine projects that the PJM Board of Managers approved on July 30, 2025. The cost responsibility for these nine projects has not changed. In addition, PJM filed revisions to Schedule 12-Appendix A to reflect a ministerial update regarding a project that crosses state boundaries to demarcate the extent of transmission line segments in each state. Specifically, these proposed revisions split the original b4000.6 project into the updated b4000.6 and new b4000.15 projects to demarcate the Virginia and West Virginia portions of the original b4000.6 project.<sup>3</sup> Finally, the filing corrects an administrative error in PJM's March 28, 2025 RTEP filing, which incorrectly named Delmarva Power & Light (DPL) as the Designated Entity for the construction of a project that was supposed to have been designated to Silver Run Electric, LLC (Silver Run). correct this administrative error, PJM proposes to delete the project from DPL's Schedule 12-Appendix A and include it in Silver Run's Schedule 12-Appendix A. In this order, we accept the proposed revisions to Schedule 12-Appendix A, effective November 26, 2025.

- 2. Notice of PJM's filing was published in the *Federal Register*, 90 Fed. Reg. 42574 (Sep. 3, 2025), with interventions and protests due on or before September 29, 2025. Timely motions to intervene were filed by: American Electric Power Service Corporation; Calpine Corporation; Dominion Energy Services, Inc.; Exelon Corporation; Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM; Old Dominion Electric Cooperative; Public Citizen, Inc.; Rockland Electric Company; and Southern Maryland Electric Cooperative, Inc. No protests were filed.
- 3. Pursuant to Rule 214 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.214 (2025), the timely, unopposed motions to intervene serve to make the entities that filed them parties to this proceeding.
- 4. We review the proposed revisions to Schedule 12-Appendix A to determine whether PJM appropriately followed its Tariff when assigning cost responsibility for baseline upgrades in the RTEP.<sup>6</sup> Based on our review, we find that PJM has appropriately followed the provisions of its Tariff, and note that the assignments of cost responsibility addressed in this order may be affected by the outcome of a complaint filed by Neptune Regional Transmission System, LLC (Neptune) and LIPA

(together, Neptune/LIPA) in Docket No. EL21-39-000,<sup>7</sup> as well as an order on the remand of *Consolidated Edison Co. of N.Y. v. FERC.*<sup>8</sup>

5. Accordingly, we accept PJM's proposed revisions to Schedule 12-Appendix A of the Tariff to incorporate cost responsibility assignments in the RTEP update, effective November 26, 2025, as requested. We also accept PJM's proposed revisions to Schedule 12-Appendix A of the Tariff to reflect scope changes, the ministerial update, and the administrative error correction, effective November 26, 2025, as requested.
