PJM Interconnection, L.L.C.

On November 4, 2025, PJM Interconnection, L.L.C. (PJM) submitted revisions to the Amended and Restated Operating Agreement of PJM, Schedule 12, and Reliability Assurance Agreement among Load Serving Entities in the PJM Region (RAA), Schedule 17, to update these lists to include new members, remove withdrawn members, reflect the signatories to the RAA, and reflect member corporate name changes for the first and third quarter of 2025.¹ PJM requests that the filing be accepted effective September 30, 2025. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, the submittal is accepted for filing effective September 30, 2025, as requested.²

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission’s regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene and any motion to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the applicant.
